

# District Cabinet Meeting Report

## Children's Vision Screening

03/04/2016

**Training Sessions:** Training Sessions for the PlusoptiX screeners were held in DeForest, Beloit, Fitchburg, and at the District Convention earlier this afternoon at the Marriott in Middleton. More than 70 Lions and Lioness have participated during this past year. More clubs are getting involved and expanding their involvement in the program.

**CVS Screening Equipment:** WLF received a grant through LCIF last year of \$100,000.00 for matching funds to purchase digital screeners. Each District was allowed to purchase up to 3 screeners either by individual clubs or by the District. In our District, Verona, Lake Wisconsin, and 27-D1 each matched approximately \$3200 to secure a screener. Beloit Lions received a local donation to match funds and also purchased a screener. With the District purchase we are able to house a screener in southwest Wisconsin at Lancaster for loan to area clubs. There are a total of 16 cameras (screeners) owned by area clubs and the District.

**CVS State Committee:** In light of the screening grant, WLF has established a statewide committee to organize and oversee the vision screening program in conjunction with PBW. As District Chair, I was requested to be a part of the committee and we have met three times during the last year in Rosholt. With the grant, WLF has reporting requirements needing club cooperation. Topics of discussion and areas needing resolution are HIPPA regulations versus reporting information, responsibility of follow-up for referrals, contact for follow-up, format of reporting to WLF and PBW, and information forms to share with families. Needless to say, there are some diverse opinions needing resolution.

**Result Reporting:** I would encourage all clubs to report their screening totals to PBW and to the district chair (via e-mail is easy!) Currently, WLF is requesting District Chairs to report their numbers on a monthly basis, but changes are in the works. As soon as an agreed upon format is decided for reporting results, we will share that information and request all clubs to please follow in reporting their screening numbers.
