27D1 Vision Screening is proud to report that most clubs are at pre pandemic screening numbers and some are reporting that they have had interest from new screening locations. Our numbers are above 10,000 screened and over 1,000 referrals that puts our average at 9.65% referrals.

It is a busy year working with WLF on refining their "Train the Trainer" program. We have been into this program for almost one year now and WLF is beginning to give access to updates on their information and guidelines for the State of Wisconsin.
