The audit of the financial records of District 27-D1 for the period July 1, 2013 through June 30, 2014 was completed on July 17, 2014. The results were presented and discussed with Immediate Past District Governor Bob Faliveno, District Governor Randy Harrison, First Vice District Governor Richard Schwedrsky, Second Vice District Governor Eric Holthaus, and Cabinet Secretary/Treasurer Bill Severson.
